- Applicant names, social security numbers and addresses for the past 7 years.
- Employer names and addresses for the past 2 years.
- Credit information - names, addresses, account numbers, balances and monthly payments on all loans and credit cards.
- Bank accounts - names, addresses and account numbers for all checking and savings accounts.
- Most current 3 months of bank statements.
- Most current 2 years of W-2's and 1040's.
- Most current 30 days worth of pay stubs.
- Real estate - loan and rental information for all property owned.
- Certificate of eligibility or DD214 (VAOnly).
- Photo ID and social security card
- Check for appraisal and credit report fees.
